Results of General Meeting and Scheme Meeting

Thorn Group Limited (ASX:TGA) (**Thorn**) is pleased to announce that at the General Meeting and Scheme Meeting held earlier today, Thorn shareholders passed resolutions to approve the Scheme Consideration Resolutions and the scheme of arrangement between Thorn and its shareholders under which Somers Limited (**Somers**) proposes to acquire all of the ordinary shares in Thorn that it does not already own (**Scheme**), as referred to in the Explanatory Booklet published via the ASX on 24 October 2023 (**Explanatory Booklet**).

Defined terms in this announcement have the meanings given to them in the Explanatory Booklet.

Voting results for the General Meeting and Scheme Meeting

For the purpose of ASX Listing Rule 3.13.2 and subsections 251AA(1) and (2) of the Corporations Act 2001 (Cth) (**Act**):

- at the General Meeting, each of the Scheme Consideration Resolutions were passed by the requisite majorities of Thorn shareholders with:
 - 97.28% of votes cast by Thorn Shareholders (other than the Excluded Shareholders) present and voting (either in person or by proxy) in favour of the Financial Assistance Resolution; and
 - 97.40% of votes cast by Thorn Shareholders (other than the Excluded Shareholders) present and voting (either in person or by proxy) in favour of the Related Party Transaction Resolution.
- at the Scheme Meeting, the Scheme Resolution was passed by the requisite majorities of Thorn Shareholders with:
 - 82.29% of Thorn Shareholders (other than the Excluded Shareholders) present and voting (either in person or by proxy) in favour of the resolution; and
 - 89.53% of votes cast by Thorn Shareholders (other than the Excluded Shareholders) present and voting (either in person or by proxy) in favour of the Scheme Resolution.

The poll report for the General Meeting and the Scheme Meeting submitted by the Returning Officer appointed by Thorn is attached to this announcement.
